TREASURY REPORT (reported by Commissioner Wood)

Prior to meeting, two checks were mailed. First check was for \$63,218.75 and sent out for the Fire Protection Agreement. The second check was for \$15,000 and sent out for the Engine Bay floors.

Beginning balance in account as of 12/11/18 was \$871,954.19. After disbursements of checks for the Fire Protection Agreement, the Engine Bay floors and then tonight's disbursements, the balance as of today, balance is \$747,128.97.
