Chiefs Report – reported by Asst Chief Sadler

- 9 calls for July
- New fire radios are in for #902. They have been programmed and are operational.
- Commissioner Wood went over what is left over in Capital with Assistant Sadler. Items that have to be discussed and reported back as purchased or to be purchased before the end of the year:
 - Scott bottles – all have been purchased for the year.
 - Helmet lights were purchased.
 - Two battery Sawzalls - were they purchased?
 - Confined space fans – were they purchased?
 - New fire hose purchased – Ken Skalla ordered. There were discussions around what was purchased and where it was placed. This will be reviewed with the Chief.
 - \$2,000 for electrical cords – were they purchased?
 - \$2,000 for life jackets - were they purchased?
 - Turnout gear?
 - Boots – 6 pair were estimated to be purchased this year.
 - Helmets – 2 of 9 were purchased this year so far. These were replacements purchased for the Chief and Assistant Chief. It was brought to Commissioner Wood's attention that they have to look at the red helmets they have. Some may have to be purchased/replaced next year.
 - As per FF Ray – all gear is well within compliance.

Engineers Report - reported by Ken Skalla

- Annual service is done. Results of any deficiencies are being drawn up at Fire and Safety.
- #901 – rear tire replacements are ordered. They will be installed on Thursday. That will complete all new tires on all apparatuses. #904 tires are not changed yet as it is new engine.
- #902 - Replaced 1 roof lightbulb.
- #903 - Right front directional was replaced; also repaired the front tie line.
- #907 – still out of service
- #908 – check engine is on – Found out the fuel injectors are defective. They are being fixed at the dealership because it is under warranty. May be out of service until Thursday.
- #909 left front drivers light is out. This will be replaced.
- Ken announced that James Thigpen is the new secretary of the fire house.

TREASURY REPORT (reported by Commissioner Wood)

Beginning balance in account as of 8/13/19 is \$335,770.70. After tonight's disbursements, balance as of today is \$258,019.28.

Quick review of budgets – all is in the black except Radio M&R and Election expenses. Commissioner Wood will review these two accounts more closely with the Chief.

We received a refund from Workmen's Comp of \$2,963.00.
